RANAF A MENS EXTENDED SQUAD LIST - 2020 AUSTRALIAN DEFENCE FORCE AUSTRALIAN RULES ASSOCIATION (ADFA) NATIONAL CARNIVAL

1. THE 2020 ADFAR NATIONAL CHAMPIONSHIPS WILL BE CONTESTED IN MELBOURNE OVER THE PERIOD 15-21MAR20, AND IS AN ADF SPORTS COUNCIL (ADSC) APPROVED ACTIVITY WITH MENS AND WOMENS TEAMS REPRESENTING NAVY, ARMY AND AIR-FORCE
2. THIS SIGNAL ADVISES OF THE RANAF A MENS EXTENDED SQUAD OF PLAYERS UNDER CONSIDERATION FOR SELECTION TO REPRESENT NAVY AT THE NATIONAL CARNIVAL. INDIVIDUAL COMMANDS WILL BE ADVISED BY SIGNAL NLT 24JAN20 ON THE FINAL SELECTIONS WHEN THE MENS PLAYING SQUAD IS REDUCED TO APPROXIMATELY 40 PLAYERS. COMMANDING OFFICERS ARE REQUESTED TO FAVOURABLY SUPPORT THE FORECAST RELEASE OF THESE PROSPECTIVE PLAYERS IOT GIVE NAVY THE BEST POSSIBLE CHANCE OF NATIONAL SUCCESS
3. CAMP. A TRAINING CAMP FOR THE FINAL SELECTED NAVY SQUAD (MEN AND WOMEN) WILL BE HELD AT HMAS CERBERUS FROM 08-14MAR20 IN PREPARATION FOR THE CARNIVAL 15-21MAR20. ALL PLAYERS WILL BE ACCOMMODATED AND VICTUALLED AT HMAS CERBERUS FROM 07-23MAR20, RETURNING TO THEIR RESPECTIVE UNITS AM 23MAR20
4. TRAVEL. A BUS WILL BE PROVIDED FOR ALL PERSONNEL RESIDING IN SYDNEY AND CANBERRA AREAS TO TRAVEL TO AND FROM MELBOURNE. WHERE SERVICE TRANSPORTATION IS NOT AVAILABLE, TRAVEL WILL BE THE RESPONSIBILITY OF THE PARENT UNIT. TRAVEL IS TO BE ARRANGED IN ORDER TO ARRIVE AT TULLAMARINE AIRPORT NLT 1600 07MAR19. SERVICE TRANSPORT WILL DEPART THE AIRPORT FOR HMAS CERBERUS AT 1700 AEDST AND IS THE ONLY SERVICE TRANSPORT AVAILABLE ON SATURDAYS. RANAF A RUNS ON A TIGHT AND LIMITED FUNDING MODEL, SO COST CONSCIOUS TRAVEL IS VITAL

7. SUBJECT TO COMMAND APPROVAL, PLAYERS ARE TO CONFIRM THEIR AVAILABILITY VIA EMAIL TO THEIR RELEVANT TEAM MANAGER AS SOON AS POSSIBLE BUT NLT 20JAN20. NIL RESPONSE WILL INDICATE UNAVAILABILITY. ALL PLAYERS MUST BE MEDICALLY FIT AND IR COMPLIANT TO PARTICIPATE AND HAVE COMMAND APPROVAL. ADDITIONALLY FOR THE 2020 CARNIVAL PLAYERS WILL BE REQUIRED TO PASS A FOOTBALL BASED FITNESS TEST AT THE BEGINNING OF THE TRAINING CAMP TO BE ELIGIBLE FOR SELECTION.
